

NIWF boasts a network of members and coordinators spread across all seven provinces, ensuring a wide reach and impactful presence throughout the country.

Over the past 26 years, NIWF has made notable progress in shaping policies concerning Indigenous Women and Girls. NIWF has significantly expanded its networks and secured substantial funding, enabling it to engage in various initiatives aimed at empowering Indigenous Women and Girls economically, socially, and politically. The organization has been actively involved in policy review, recommendations, and research. NIWF has also advocated for highly marginalized Indigenous Nationalities in Nepal, such as the Bankariya and Chepang communities. NIWF will continue advocating for the rights of Indigenous Women and Girls.



NIWF conducted a round table discussion on the Policy Review of Indigenous Migrant Women

Ms. Mala Rai presented the findings of NIWF's research on Indigenous Returnee Migrant Women (IRMW), offering insights into the difficult realities these women face upon returning to Nepal. She also explained the research methodology, emphasizing the use of Feminist Participatory Action Research (FPAR) to ensure the study reflected the voices and lived experiences of IRMW.

Ms. Uma Tamang then discussed the policy brief on Indigenous Migrant Women, outlining the gaps in current policies and legal frameworks. She stressed the need for more inclusive policies that address the unique needs of Indigenous migrant women, calling for stronger legal protections, tailored economic opportunities, and support systems for reintegration. The session concluded with an open discussion where participants provided valuable

feedback and recommendations.

Relief Distribution at Temal Rural Municipality

On October 7, 2024, National Indigenous Women Forum (NIWF) in collaboration with Sankalpa extended critical relief to flood-affected families in Temal Rural Municipality, Kavre district. In response to the devastating floods that struck the area on September 26-27, 2024, NIWF swiftly mobilized a team to support the community. The team provided essential food supplies to 32 families who had been severely impacted by the disaster, aiming to alleviate their immediate hardships and address urgent needs. The floods caused widespread damage to homes and livelihoods, leaving many families struggling to recover.

This support is part of NIWF's broader mission to empower and protect Indigenous Women, Girls, and Marginalized Communities across Nepal, particularly in moments of adversity.



Opening of Our "Aadivasi HaatBazaar" at Dhobighat Basketball Ground

On October 27, 2024, National Indigenous Women Forum (NIWF) and Indigenous Product Outlet hosted a successful "Aadivasi Haat Bazaar" at the Dhobighat Basketball Court. This event was organized to create a vibrant platform for Indigenous Women to present, promote, and monetize their products, amplifying their economic independence and cultural pride. The Bazaar featured an array of traditional and sustainably produced items that highlighted the rich heritage and craftsmanship of Nepal's Indigenous Communities. Visitors had the opportunity to explore and purchase a diverse selection of goods, including authentic Indigenous foods, intricately handmade crafts, and fresh, organically grown vegetables. Notably, the vegetables were cultivated by the Sankharpur Integrated Pest Management (IPM) group of NIWF, reflecting the Forum's commitment to promoting ecofriendly farming practices within Indigenous communities.



NIWF's Media and Communication Assistant at the 2nd Cohort of Holistic Security Training in Bangkok

From October 21st to 23rd, 2024, Ms. Anisha Buda, the Media and Communication Assistant at the National Indigenous Women Forum (NIWF), participated in the second cohort of the Holistic Security Training. At CBD COP16 in Cali, Colombia, National Indigenous Women Forum (NIWF)'s Chairperson Suni Lama, along with Indigenous leaders from Nepal, collaborated with Nepalese government delegates to present a draft of the National Biodiversity Strategy and Action Plan (NBSAP). As steering committee members, NIWF and NEFIN played an active role in shaping the draft, emphasizing Indigenous Peoples' perspectives, traditional knowledge, and the protection of Indigenous rights within biodiversity conservation policies. Through the active involvement of NIWF and NEFIN on the NBSAP steering committee, and Indigenous Biodiversity Professional Kamal Samarung who is a technical committee member of NBSAP, the perspectives of Indigenous Peoples and Indigenous women were integrated into the draft.
