Fiscal Year 2081/82 budget through Indigenous Peoples' Perspectives:

On May 3rd, 2024, National Indigenous Women Forum (NIWF) convened a closed group discussion and consultation, focusing on the Nepal Government's Fiscal Year 2081/82 budget through the lens of Indigenous Peoples' rights.

Following a closed group discussion and consultation with experts held on May 3rd, National Indigenous Women Forum (NIWF) has submitted suggestions recommendations to the Ministry of Finance, focusing on the upcoming Fiscal Year 2081/82 budget of the Nepal Government with a specific lens on Indigenous Peoples' rights. Grounded in information published by the Ministry of Finance, these recommendations aim to advocate for the rights of Indigenous Women and Girls, as well as all Indigenous Communities, within the budgetary framework.

The Bankariyas are endangered Indigenous Community of Nepal with a mere population of 180 according to the 2021 Census and a total household of 24, out of which only 86 of them speak their Mother tongue. In the 2011 National Census, Bankariyas were not recorded as they were not recognized till then.

on Preliminary Position Paper

On May 17, 2024, National Indigenous Women Forum (NIWF), supported by Asia Pacific Forum on Women, Law and Development (APWLD), conducted a consultation meeting on the "Preliminary Position Paper Draft on the Inclusive and Sustainable Implementation of the Reintegration Programme 2079" in Chautara Sagachokgadhi Municipality. The event gathered local stakeholders, including human rights defenders, journalists, government representatives, local NGOs, media, and the SaMi Project, to discuss the effective economic reintegration of Returnee Migrant Women and Indigenous Women in the municipality.

Women Human Rights Impact Assessment (WHRIA) Pilot Test:

From 28 to 29 May 2024, National Indigenous Women Forum (NIWF) together with Asia Pacific Forum on Women, Law and Development (APWLD) and the Center for Economic and Social Rights (CESR) conducted Women Human Rights Impact Assessment (WHRIA) Pilot Test: Addressing Gendered Impacts of Development Projects. The impact assessment was conducted in the Majhi Communities in Manthali to determine the status of the hydropower dam project and assess the human rights situation of the Indigenous Women, particularly in exercising their right for participation, access to information and self-determination.

Press Conference on WHRIA Pilot Test Findings:

On May 30, 2024, National Indigenous Women Forum (NIWF), in collaboration with Asia Pacific Forum on Women, Law and Development (APWLD) and Center for Economic and Social Rights (CESR), held a press conference at the Kathmandu Guest House to present the findings of the WHRIA Pilot Test, focusing on the gendered impacts of development projects. During the conference, NIWF's Vice-Chairperson Ms. Yasso Kanti Bhattachan provided a brief background on the Sunkoshi Hydropower Dam. Representatives from the Majhi Community—Sukumaya Majhi, Mamta Majhi, and Purna Majhi—shared powerful testimonies about how the hydropower project and climate change have affected their lives.


