### INTRODUCTION

National Indigenous Women Forum-NIWF was established in 1998 with the mission and vision to eradicating multiple forms of discrimination experienced by Indigenous Women and Girls of Nepal. Indigenous women, being Indigenous peoples, face racial, linguistic, religious, cultural, economic, and political discrimination and exclusion. Also, Indigenous Women, being women, face gender discrimination. Empowerment and strengthening of Indigenous Women is a must to end all forms of racial and gender discrimination, exploitation, suppression, and oppression against Indigenous women. Acceptance of the multi-caste and ethnic, multi-lingual, multi-religious, and multi-cultural reality of Nepali society by the People's Movement of 1990 has indeed paved the way for non-governmental organizations to contribute to the empowerment and strengthening of Indigenous peoples, women, and other excluded groups and communities.

In this backdrop, NIWF was founded in 1998. There are not only common problems and issues of Indigenous Women and other women and also of Indigenous women and Indigenous men but also distinct problems and issues that are unique to Indigenous women. Therefore, the NIWF was established to support and raise awareness of Indigenous women, to intensify advocacy for securing the rights of Indigenous women and Indigenous children, and to run programs with focus on advocacy, training, discussion, interaction, study, and research as needed.

#### WE ARE NATIONAL INDIGENOUS WOMEN FORUM

National Indigenous Women Forum (NIWF) works with indigenous women and girls across Nepal to empower and support them in securing indigenous women's rights. We focus on solving the root causes of vulnerability and exclusion of indigenous women and girls. From the grassroots to policy level, we come together to intensify advocacy for securing rights of indigenous women and indigenous girls, and run programs with focus on advocacy, training, discussion, interaction, research and publication as needed.

#### NIWF MISSION

Advocate ensuring the rights of highly marginalized and endangered Indigenous peoples, particularly women and girls.

#### **NIWF VISION**

Promoting the social, cultural, political and economic rights of Indigenous Women. Our Constituencies NIWF works with Indigenous women and girls across Nepal. In doing so, NIWF emphasises on the intersectionality of Indigenous women and girls. Indigenous men are not direct beneficiaries of our interventions, however, their engagement is valued as and when required. NIWF is led my Indigenous women where all the Board members are cis-women.

### **Executive Summary**

NIWF has outlined a strategic plan for 2022-2026 with the vision of achieving a 50:50 gender ratio in Indigenous women's leadership across all decision-making levels. To ensure this plan's success, we have collaborated with Indigenous Women leaders at the local, provincial, and federal levels. Our mission focuses on enhancing access for endangered and marginalized Indigenous women by developing their capacities across various sectors. This year, our efforts included the "Santoshi Project," which aims to empower the endangered Bankariya Indigenous People of Nepal. Through this initiative, we provided education to 40 Bankariya children and empowered Ms. Santoshi Bankariya as a community leader.

Additionally, we offered soap-making training to the Bankariya community, promoting economic empowerment and biodiversity conservation. Our broad areas of work encompass Economic Justice, Social Justice, and access to Justice, Climate Justice, and Gender Justice. With the support of Women Fund Asia, we advanced the understanding of CEDAW General Recommendation Number 39 among elected Indigenous Women Representatives from Sudurpaschim and Madhesh Provinces. We also capacitated members of the Women and Social Affairs Committee of the House of Representatives and lobbied for the implementation of CEDAW GR-39. This year, our partners included MADRE, WFA, IUCN, MAMA CASH, UNDP, DCA, and APWLD.

We are deeply grateful for their unwavering support. NIWF had significant opportunities to participate in international forums, including organizing a parallel event, "Empowering Dalit and Indigenous Women and Girls in Nepal," during the 68th Session of the Commission on the Status of Women in New York, and participating in various high-level meetings such as the SBSTTA of the CBD in Nairobi and the United Nations Permanent Forum on Indigenous Issues in New York. The parallel event at the 68th High-Level Political Forum was a notable activity, advancing the rights of Indigenous Women and Girls. This report details NIWF's achievements and the challenges faced throughout the year. Thank you to our donors and partners, including MAMA CASH, MADRE, UNDP, APWLD, Women Fund Asia, and DCA, for their invaluable support.

### **KEY STRATEGIC AREAS**

### Lobby and advocacy

NIWF employs a bottom-up approach to engage with Indigenous Women at the grassroots level, extending its influence to local, national, and international spheres. We focus on building advocacy and lobbying skills for Indigenous women at both grassroots and policy-making levels. Our vision of achieving gender parity (50-50) is



pursued through mentorship and continuous support for local leaders.

At the international level, NIWF continues its strategic implementation of CEDAW General Recommendation No. 39, fostering the Indigenous Feminist movement. We have expanded the reach of Indigenous Women and Girls by participating in key platforms such as the Commission on the Status of Women, the United Nations Permanent Forum on Indigenous Issues, the Conference of the Parties (Biodiversity and Climate Change), and the High-Level Political Forum. These platforms are crucial for strengthening the Indigenous Women's rights movement and highlighting issues faced by Indigenous Women and Girls in Nepal.

With the support of Women's Fund Asia, We have been able to capacitate the Indigenous Women Leaders of Provincial and Federal including national level parliament. NIWF has given them self-monitoring, self-assessment and selfmonitoring, negotiations, and the prevailing issues of Indigenous Communities. For the past 25 years, NIWF has been advocating for the rights of Indigenous Women and Girls, making significant strides. This year has been particularly



momentous, with Humlu Indigenous communities gaining state recognition. Additionally, the Nepal government has declared Tamang and Nepal Bhasa as official languages in Bagmati Province. NIWF successfully submitted a

memorandum to the Ministry of Agriculture and Land in Bagmati Province, advocating for the betterment of the Bankariya Indigenous Community, a highly endangered Indigenous group.

Our efforts to implement CEDAW General Recommendation No. 39 include advocating with Indigenous Leaders in parliament to bring these issues to the House of Representatives. NIWF has also actively worked on the Education Bill and Civil Service Bill, pushing for the inclusion of Indigenous issues in government policies.

### **Capacity Building and Community Empowerment**



NIWF is dedicated to the capacity building of staff, board members, and community groups. This commitment not only enhances community capacity but also ensures smooth organizational functioning. We have empowered Indigenous

Women Parliamentarians and local representatives on issues affecting Indigenous Women and Girls. Our work with CEDAW General Recommendation No. 39, an international instrument protecting the rights of Indigenous Women and Girls, reflects our rigorous efforts for its meaningful implementation.





We have increased youth participation in various forums, fostering leadership and exposure. Our initiatives have strengthened grassroots climate resilience and equipped Indigenous Women Leaders with knowledge of climaterelated national and international policies. Additionally, NIWF has established a minilibrary for the Bankariya Community in

Makawanpur, providing educational resources to support their learning and development.

#### Addressing the Climate Crisis and Indigenous Rights

The climate crisis poses a significant threat to Indigenous communities in Nepal, leading to displacement from ancestral lands and territories, adverselv impacting their livelihoods, and frequently resulting in the violation of their rights by the government under the guise of climate and biodiversity protection. NIWF's core mission is to build climate-resilient Indigenous communities while respecting and



promoting Indigenous knowledge and practices. To this end, we have been empowering Indigenous Women and Girls with knowledge of climate-related national and international frameworks, enabling them to advocate effectively at the grassroots level. NIWF has trained 10 Indigenous Women Groups in Integrated Pest Management, significantly benefiting the lives of Indigenous Women and Girls This Year we have been able to distribute essential materials to 100 families



of Rukum West who were affected by the devastating earthquake.

This year, NIWF documented the Indigenous knowledge of the Bankariya, Danuwar, and Tharu communities in Makawanpur, Kavrepalanchok, and Kapilvastu, respectively. We also provided these women with leadership and entrepreneurship training, enhancing their capacity to contribute to their communities. NIWF has actively advocated on international platforms, gaining insights into various international mechanisms through participation in conventions such as COP and GEO-7. Additionally, NIWF has played a vital role in national policy reform, serving on the steering committee of the National Biodiversity Action Strategic Plan. We have also prepared a position paper on the Convention on Biological Diversity Target-3 from the Indigenous perspective, focusing on land and territories.



### **Research and Institutional Development**

NIWF has been actively engaged in Feminist Participatory Action Research, contributing to the creation of knowledge and fostering community involvement. Our research initiatives include an in-depth study of Indigenous Returnee Migrant Women in Sindupalchok and an analysis of the social and economic conditions of Kamalaries residing in Sudurpaschim Province. In our continuous efforts to support highly endangered Indigenous



communities, we have produced and disseminated key reports such as "A Report on the Situation of Gender-based Violence against Chepang Women in Ichchhakamana Rural Municipality, Chitwan," and "A Policy Review of Ichchhakamana Rural Municipality's Policies and Programs for FY 2023/2024 (2079/2080 BS) from Gender Equality, Social Inclusion, and Indigenous Perspectives." These documents serve as essential tools for advocacy and future reference.



This year, NIWF celebrated its 25th Anniversary Silver Jubilee, reflecting on our achievements and refining our future objectives. The event provided an opportunity to evaluate our progress and set strategic goals for the coming years. Additionally, NIWF has submitted the "NGO Joint Submission for the Pre-Sessional Working Group (19-23 February 2024) Indigenous Women and Girls' Perspective'' for the Universal Periodic Review. We also organized a panel discussion during the World Social Forum 2024 in Nepal.

### **International Exposure**

This year, NIWF actively participated in and organized a parallel event during the

68th Session of the Commission on the Status of Women (CSW). The event, titled "Empowering Dalit and Indigenous Women and Girls in Nepal," was co-organized with the Feminist platform Dalit Organization. This allowed NIWF lav essential to groundwork on the issues faced by Indigenous and Dalit women in Nepal.



The event was honored by the presence of the Secretary of the Ministry of Women, Children, and Senior Citizens.



Additionally, NIWF representatives took part in several significant international forums, including the Convention on Biological Diversity (CBD) in Nairobi, the High-Level Political Forum, and the United Nations Permanent Forum on Indigenous Issues. These engagements were pivotal in highlighting the concerns of Indigenous and Dalit

communities on a global stage. NIWF also participated in two GEO-7 dialogues, which were crucial for ensuring the inclusion of Indigenous Peoples' issues in the

report. Furthermore, the organization engaged in media and communication training and received training on the Environment Human Rights Defenders Toolkit, enhancing our capacity to advocate for Indigenous rights effectively.
